Practice monitor and exclusion conditions Policy

1. Purpose

The Health Practitioner Regulation National Law (NSW) states that the protection of the health and safety of the public must be the paramount consideration when functions are being exercised under that law. Practice monitor and exclusion conditions are designed to protect the public whilst allegations of sexual assault or misconduct are dealt with by the appropriate body and may be imposed as a result of Council convening urgent proceedings under section 150 of the Health Practitioner Regulation National Law (NSW).

This policy sets out permissible exclusionary conditions that delegates may impose in relation to the practice monitor and exclusion conditions listed in the Council's Conditions Handbook.

2. Mandatory Requirements

Practice monitor and exclusion conditions either:

- 1. require a Council approved practice monitor to be present when the practitioner has contact with a patient in the identified patient group; or
- 2. prohibit the practitioner from having contact with a patient in the identified patient group.

Permissible exclusionary conditions in relation to sexual boundary crossing are:

- children/young person
- gender (as self-identified)
- all patients

Exclusion for other age ranges, for example female patients between the age of 12-50 years are not in accordance with this policy.

3. Definitions

Term	Explanation
child/children/young person	a person/s under the age of 18 years.
contact	includes any consultation, examination, treatment, procedure, interview, assessment, prescribing for, advising, or otherwise seeing a patient, whether or not the patient is physically in the presence of the practitioner.
identified patient group	a category of individuals referred to in a condition imposed on a practitioner's registration.
patient	a person who belongs to the identified patient group.
practice monitor	A medical practitioner, nurse or midwife with current Australian registration who has been approved by the Medical Council of NSW to monitor the practice of a practitioner who is the subject of a practice monitor condition.
